- 443 Martin Street is a CMX1 building, variance is being sought for use as 2 family use which is not permitted due to adjacent RSA zoning
- History is given of residential and commercial rental at this property etc. Property has been in his family for some time.
- Seeks to legalize current use as a duplex
- An adjacent neighbor was concerned about the use of 2 parking spaces where it was previously only 1 space
- Discussion concerning impervious surfaces and 2 car parking and owner should consider additional plantings and greenspace
- Poll was launched and the majority supported the application for 2 units
